

HIGHLIGHTS OF ECONOMIC SURVEY-2021-22

- 1 State's economy is expected to witness GDP growth of 8.3 percent in 2021-22.

- 2 The GSDP of State at current prices in the year 2021-22 is estimated at ₹1,75,173 crore.

- 3 Per capita income at current prices is estimated at ₹2,01,854 during 2021-22 which is 10.1 per cent higher than 2020-21.

- 4 Agriculture and allied sector have been the least impacted sector by the pandemic and the sector is expected to grow by 8.7 percent in 2021-22.
