29TH HIMACHAL PRADESH STATE SHOOTING CHAMPIONSHIP IN RIFLE SMALL BORE, PISTOL & SHOTGUN EVENTS AT SHIMLA FROM 13TH TO 17TH JUNE 2024

- 1. We wish to inform you that Himachal Pradesh State Rifle Association (HPSRA) is conducting the 29th HP State Shooting Championship from 13th to 17th June 2024 at the followings venues:-
 - 10mtr Rifle & Pistol events at Indira Gandhi Sports Complex, Shimla from 13th to 16th June 2024.
 - (b) Trap, 50mtr Rifle, 50mtr Pistol and 25mtr Pistol at CHEOG near Fagu (Shimla) 13th to 17th June 2024.
- 2. This will be organized and conducted by the Himachal Pradesh State Rifle Association. The terms and conditions are as under:-
- 3. Participation is open to competitors from Himachal Pradesh.
- 4. The competition will be conducted in individual event only.
- 5. The <u>entries</u> and <u>entry fee</u> will only be accepted through "NRAI's ONLINE SYTEM". No paper entry and entry fee will be accepted except list of matches attached at Appendix "A". Shooters are required to visit NRAI website <u>www.thenrai.org</u> to file their online entries. The online entries will be accepted till 23:59 PM on 12th June 2023. The entry fee once paid will not be refunded under any circumstances. The following scanned documents are required for registration with NRAI Online System:-
 - (a) Passport size photograph.
 - (b) Address Proof.
 - (c) Birth Proof (Birth certificate or Matric certificate).
 - (d) Online payment of Rs. 590.
 - (e) Affadavit as per format https://thenrai.in/Downloads.aspx?link=30
- 6. Age Limit.
 - (a) Juniors 21 years Born in 2003 or after.
 - (b) Youth 19 years or before Born in 2005 or after
 - (c) Sub Youth 16 years or before Born in 2008 or after
 - (d) Masters 45-60 years Should have completed 45 years one day before Competition
 - (e) Senior Masters 60-70 years Should have completed 60 years one day before Competition.
 - (f) Super Masters 70 years Should have completed 70 years one day before Competition.
 - (g) Under 12 Should have below 12 years on the first day competition.



- 7. For any recognized competition the minimum age for participation in firearms events is 12 years and 10 years for air gun events (except under 12 supported standing). ONLY a competitor who has completed the age of 12 years (for Firearms events)/10 years (for Air Gun events on the first day of the competition including state / zonal / AIGVMSC or any other competition recognized by the NRAI will be permitted to participate in competitions being conducted under NRAI Match Book.
- 8. The shooters are requested to download their competitor card duly login on NRAI website www.thenrai.org as the same will not be issued at the shooting range.
- 9. A shooter will be eligible to participate in the AIGVMSC / North Zone only if he or she has achieved the minimum qualifying score as per NRAI Match Book Rule No. 1.4. Shooters from other states can also participate as guest entry in the Matches but no Medal or Certificate for participation will be given unless they take HPSRA Life Membership.
- Individual medals will be awarded as under:-
 - (a) 3 medals where there is a minimum of 4 entries.
 - (b) 2 medals where there is a minimum of 3 entries.
 - (c) 1 medal where there is a minimum of 2 entries.
 - (d) No medal in case there is a singly entry.
 - (e) Senior, Super master's and under 12 category shooters are exempted from above.
- 11. Protest fee is Rs. 200/- and in case an appeal is filed with the Jury of Appeal, then the fee is Rs. 500/- The fee will be returned if the protest is upheld and retained by the Organizers if the protest is lost.
- 12. The Organizers will have the right to close any match or event in case of any emergency or otherwise without assigning any reason for such an action on their part.
- 13. The Organizing Committee reserves the right to amend the rules at any time at its sole discretion for events/circumstances beyond its control.
- 14. Any decision made by the Organizing Committee in any such matter will be final.
- 15. All participants are expected to abide by the rules and regulations for the competitions.
- 16. Discipline on and off the field is very essential.
- 17. In case of non-participation by the competitors after submission of their entries will not be allowed any refund of the Entry Fee.
- 18. The required ammunition for practice and competitions will be provided against cash payment to the competitors subject to the availability of ammunition. Shooters will have to make their own arrangements for boarding & lodging.
- 19. The following weapon will be provided at Shooting Ranges by the HPSRA:-
 - (a) 12 Bore
 - (b) .22 Peep Sight Rifle
 - (c) .22 Open Sight Rifle
 - (d) .177 Air Rifle and Air Pistol
- 20. Entry fee is neither refundable nor adjustable or transferable from one match to another or from one shooter to another.
- 21. All matches of similar nature will be fired concurrently but the entry fee shall be paid separately for each event.
- 22. Shooters furnishing wrong information regarding their previous participation and date of birth shall be debarred from taking in any championship for two years.

- 23. The Competitors shall observe strict safety regulations and range discipline and shall not load or commence firing unless on the firing line and only when appropriate firing order is given by the Range Officer. The competitors shall carry all weapons with bolts/actions open at all the times except on the firing line. The decision of the appropriate Jury shall be final in all such matters.
- 24. All scoring protests must be submitted within 30 minutes after the official scores are posted on the main score board. The time when the scoring protest time ends must be posted on the main score board. A protest fee of Rs. 200/- per individual result must be paid to the Organising Secretary along with the protest. The fee will be returned if the protest is upheld and retained by the Organizing Committee if the protest is lost.
- 25. The shooters participating in shooting competitions should appear like sports persons and no unsporting clothing should be used by the shooters and they should come to the ranges/prize distribution with proper uniform. The following shall not be used by the shooters during shooting competitions: Chappals, sandals, Jeans, Sleeve less tops, mini skirts and all type of pants and shorts with external pockets like cargo pants and shorts.
- 26. Participation in this championship is mandatory for the shooter desirous to further participate in North Zone/AIGVMSC
